

Scholarship Application Information

Purpose

The purpose of the Lubbock SHRM Certification Scholarship is to provide financial assistance to LSHRM members who are interested in obtaining SHRM-CP or SHRM-SCP Certification and are not being reimbursed from their employer or other sources.

Scholarship Eligibility

- Current LSHRM member (Professional or student membership must be active when applying and throughout the year in which the award is received)
- Meet eligibility requirements for SHRM Certification These requirements are outlined on the SHRM Certification website.
- Plan to sit for the exam within 9 months after the scholarship notification date
- Is not receiving any organizational support or reimbursement for the SHRM certification exam and preparation fees

Scholarship Selection Criteria

- 50% work experience/progression (HR involvement and future career plans)
 - Current students without significant work experience will be reviewed based on academic background and breadth and quality of HR coursework
- 50% volunteer activity (SHRM experience preferred, but not required)

Scholarship Selection Process

The Scholarship Application required documents must be submitted via email by **January 26**, **2024**. No exceptions will be made. The LSHRM board will evaluate the scholarship applications. The recipient of the SHRM-CP/SHRM-SCP Certification Course Scholarship will be notified by February 2, 2023 by phone or email. The scholarship will cover \$1,500 (approximate cost of certification course). Scholarship is a one-time award that must be used for the current certification course. Previous applicants and past recipients are eligible to reapply. Previous award is no guarantee of a future award.

Exam Eligibility Requirements

Applicants must meet specific educational and work experience criteria at the time they submit their application, in order to be eligible to sit for the SHRM-CP or SHRM-SCP exam. The following general eligibility criteria, listed below, also apply:

- Applicants must show that they have worked in an HR role for more than 1,000 hours within a calendar year, which equates to one year of experience.
- HR experience can be in an exempt or non-exempt capacity.
- HR experience may be classified directly, as working in an HR role, or indirectly, by consulting, educating, or educating or researching HR practices linked specifically to human resource management.
- National SHRM membership is not required
